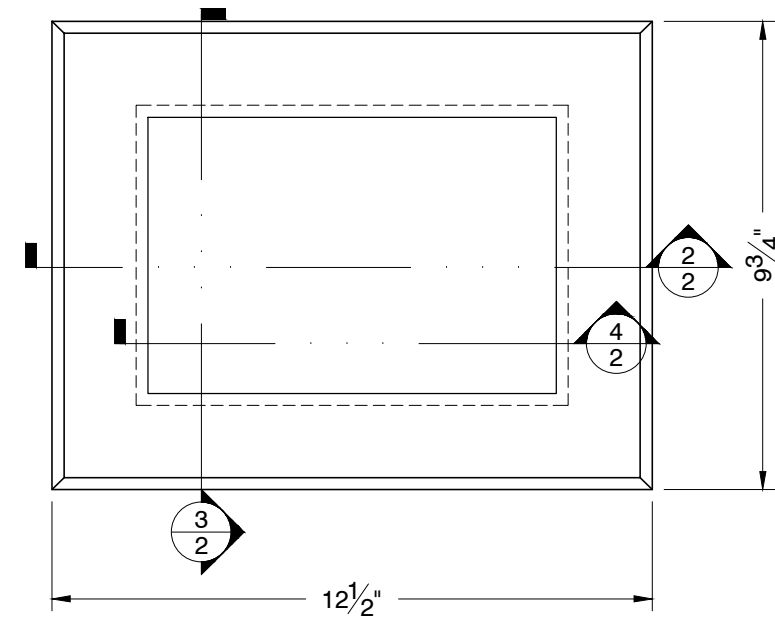
**1 ELEVATION**  
PART LID SCALE 1:4



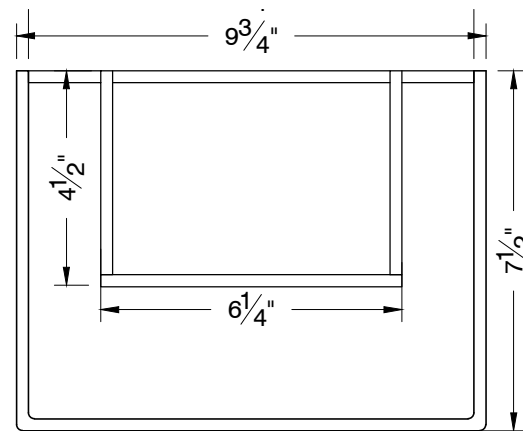
